STORAGE:	This product must be stored below -18oC until required. Packs should be used in stock rotational order (first in, first out). Once defrosted packs have a maximum chilled life of 16 days unopened and 3 days opened. It is recommended that the date of defrost and the new use by date is recorded by the end user. Under NO circumstances should defrosted packs be refrozen.
COOKING:	Bottle contents may separate on defrost however will return to their typical state once heated. Shake thoroughly prior to opening. Decant entire contents of polybottle into heating vessel for optimum distribution. Heat gently, stirring occasionally until piping hot. Handle with care. Do not reheat.
